Key Responsibilities

Donor Relationship Management

- Manage a diverse portfolio of donors (individuals, corporates, trusts, local groups, mosques etc).
- Develop and implement a tailored experience for our donor pool.
- Maintain consistent communication, thank-yous, updates, progress reports

Reporting & Impact Communication

- Write engaging, clear impact reports and updates.
- Organise donor briefings, site visits, and regular check-ins with Lonely Orphans teams
- Plan ahead and ensure certificates and recognition letters are sent out accordingly
- Develop a donor profile report for Lonely Orphans to better understand its audiences.

Fundraising Support

- Maintain a weekly email-campaign with news updates and appeals
- Support marketing and fundraising teams with key data and case studies

Data and Systems Oversight

- Maintain an accurate donor data in the CRM
- Track all donor interactions and funding history.
- Conduct donor due-diligence in line with ethical policies.

Special Campaigns and Event Support

- Collaborate with fundraising and communications teams during donor-focused events.
- Organise and coordinate donor data in time for seasonal campaigns such as Ramadan and Dhul-Hijjah

Monitoring, Evaluation & Reporting

- Provide input into fundraising strategy and performance metrics.
- Work cross-functionally to ensure donor needs are woven into programmes and communications
